In the year 2019 FAG-MA had invested in 21 startups from India. In the subsequent year the corresponding figure shot up to 32 and in the current year it stands at 57.

A study of the current year's peaking investments revealed that Google has topped the charts by funding 29 startups. Software giant Microsoft and online platform Amazon shared a distinct second spot, each investing in 12 startups.

Financial experts observed that the startup investments are spread across different sectors, thereby catering to diverse portfolios that include local delivery, e-commerce web portals besides accommodating the relatively new market entrant, namely fintech platforms like Bitcoin.

The type of Indian start-ups funded by FAMGA this year mirrors the global trend — they are spread across different sectors ranging from hyper-local delivery to e-commerce websites to marketplaces to fintech platforms.

To cite a few, Dunzo is a startup catering to home delivery in multiple product categories. Meesho, a startup venture catering to marketing needs including that of resellers too promotes sale of a diverse variety of products. Under a similar category of facilitation, is DotPe that deals with online ordering and end-to-end solutions for restaurants and their remote clients.

The financial observers concluded that this trend is likely to continue in the next few years too with Google making an announcement about its intentions to double their workforce in India.

iving up to the yellow alert given by the India Meteorological Department (IMD) for Mumbai and surrounding districts, Wednesday looked just like a day from the Monsoon season. The yellow alert was issued by IMD because of a low-pressure area formation over east central Arabian Sea off Maharashtra coast. The rainfall is likely to continue on Thursday too as per the IMD Forecast.

Directorate General of Civil Aviation postpones resumption of international flights indefinitely

The government on Wednesday cited concerns over the Omicron variant of the COVID-19 virus and indefinitely postponed full international



flights' reopening, which was scheduled on December 15.

This means international flights will continue to operate on a smaller scale and only with 31 countries with which India has air bubble agreements.

The Directorate General of Civil Aviation (DGCA) said, "In view of the evolving global scenario with the emergence of new variant of concern, the situation is being watched closely in consultation with all the stakeholders and an appropriate decision indicating the effective date of resumption of scheduled commercial international passenger services shall be notified in due course."

BMC puts off reopening of schools for Std I-VII

Civic officials said the decision was taken to ensure appropriate measures are taken for the safe return of students on the campus, amid the fear of a new Coronavirus variant. Many schools were to welcome back primary kids today.

The Brihanmumbai Municipal Corporation's (BMC) decision comes a day after the state government issued a

78 crores recovered from those without masks and Rs 94 lakhs from those who spit on the streets

The second wave of corona has been completely controlled in Mumbai, but the threat of the new corona variant Omykran has created fear all over the world. However, the number of people who were fearless from Corona has increased in Mumbai. Not only this, the number of people spitting on the streets and roaming without masks has also increased. The Municipal Corporation is taking action against 222 people walking without masks every day. According to the data received, since April 2020 till now, action has been taken against 3965261 people and a fine of Rs 788193600 has been recovered from them. At the same time, taking action against 46,998 people since September 2020, a fine of Rs 93,88,300 has been collected.

It is noteworthy that in the month of March last year, there was a corona epidemic in Mumbai. After this, the use of masks in public places has been made mandatory to protect against



corona. Although many people are ignoring it. This negligence can play an important role in increasing the spread of corona. At the same time, in view of its seriousness, the Municipal Corporation started cracking down on those who walk without masks in public places. With the help of clean-up marshals and police, a fine of Rs 200 is being imposed on people walking without masks. Similarly, a fine of Rs 200 is also being charged from those who spit on the roads. The Municipal Administration has appealed to the

people to follow the rules of wearing masks and not spitting in public places to protect against corona and other epidemics.

Most of the people caught spitting on the streets in Zone 'A' Action has been taken against most of the people spitting on the streets in Fort, Colaba, Sandhurst Road, Marine Lines, Nariman Point, Mumbai Central, Grant Road, Byculla falling in Zone A of the Municipal Corporation. According to the information, action has been taken against a total of 93 lakh 88 thousand people.

MAHARASHTRA MAKES NEGATIVE RT-PCR REPORT COMPULSORY FOR DOMESTIC FLIERS

n view of the emergence of the highly mutated Covid-19 variant Omicron, the Maharashtra government has made a negative RT-PCR test within 72 hours of departure a must for all domestic passengers.

"In case of domestic air travel, passengers travelling within the state will either have to be fully vaccinated or compulsorily carry an RT-PCR test within 48 hours of the time of arrival...In the case of passengers from other states, negative RTPCR will be compulsory without exceptions," an order released by the state government said.

Meanwhile, India may not resume commercial International flights from December 15, as announced earlier. The decision has been taken keeping "in view of the evolving global scenario with the emergence of new variants of concern".



Globally, the United States is moving to require that all air travellers entering the country show a negative Covid-19 test performed within one day of departure. Saudi Arabia, too, confirmed its first case of the Omicron Covid-19 variant coming from a north African country. Japan also joined Israel and Morocco in saying it would completely close its borders.

Earlier this week, the World

Health Organization (WHO) warned on Monday that the heavily mutated Omicron coronavirus variant was likely to spread internationally and poses a very high risk of infection surges that could have "severe consequences" in some places.

On Tuesday, health officials in the Netherlands said the heavily mutated new coronavirus variant was in Europe several days earlier than previously known.

Bank of Baroda flags-off 'Green Ride Ek Pehal Swachh Hawa ki Aur'



"The MSRTC operated 1,086 buses, including 822 ordinary ones, on various routes from 50 depots till Monday evening. On Tuesday evening, the number reached 960," a spokesperson of the MSRTC said. Till Monday, the corporation had suspended the services of 7,585 permanent employees and 1,779 daily wage workers, an official said.

STERLITE POWER'S 'URJA MARG' FOR UNINTERRUPTED SUPPLY TO MUMBAI

Sterlite Power has tightened its belt to ensure uninterrupted power supply to Mumbai, Thane and Navi Mumbai. Accordingly, it has been decided to lay a 400 KV double circuit high voltage power line of 70 km length from Central Power Grid Power Station at Padgha to Mahatrans Power Substation at Kharghar under 'Mumbai Urja Marg'. The work of this power line will be completed by the end of 2023. Therefore, it will be possible to carry more than 1000 MW of electricity to Mumbai

from all over the country including Maharashtra. Mumbai's current maximum demand for electricity is 3500 MW and it is increasing day by day. The demand for electricity in Thane and Navi Mumbai is also increasing rapidly. Also in October 2020, due to technical failure in the grid, blackout had taken place in many parts of Mumbai, Thane and Navi Mumbai. The Union Energy Department along with the state government has taken it seriously. While the state government has expedited the work of Kharghar Vikhroli 400 KV double circuit power line, now the 400 KV power

line will be brought from the 765 KV substation of Central Power Grid at Padgha to the 400 KV substation of Mahapareshan at Kharghar. Therefore, electricity from all over the country will easily reach Kharghar power substation and from there it will be easy to reach Mumbai through Kharghar Vikhroli high voltage power line. Ninad Pitale, project director of the company, said that the Central Electricity Authority (CEA) has commissioned Sterlite Power to construct high voltage power lines at Padghe Kharghar, Padghe Navi Mumbai and Apta-Kalwa.



GST COLLECTION CROSSES RS 1.30 LAKH CR FOR Commercial LPG gas cylinder SECOND STRAIGHT MONTH IN NOVEMBER: FINMIN price hiked by Rs 100: Check

s per the Ministry of Finance, India's GST **L** collection rose to Rs 1,31,526 crore in November. This was the second straight month when the gross GST collection crossed Rs 1.30 lakh crore, on both sequential and year-on-year basis, news agency IANS reported.

Besides, the GST revenue for November 2021 registered a 25 per cent growth compared to the corresponding period last year.



Out of the total gross collection, 23,978 crore and the share of SGST the total share of CGST's was Rs was at Rs 31,127 crore.

The share of IGST stood at Rs 66,815 crore and Cess was at Rs 9,606 crore.

"The GST revenues for November 2021 have been the second highest ever since the introduction of GST, second only to that in April 2021, which related to year-end revenues and higher than last month's collection, which also included the impact of returns required to be filed quarterly. his is very much in line with the trend in economic recovery," the finance ministry said.

PG prices for commercial cylinders were on Wednesday hiked by 100 per cylinder. Earlier prices of commercial LPG were hiked on November 1.

According to a report by Zee News, the increased price of LPG cylinders is effective from today.

The national oil marketing companies have increased the price of commercial 19kg LPG cylinder by Rs 100.50, taking the new price to Rs 2,101 in Delhi. While, in Mumbai it will cost Rs 2,051 per cylinder. In Kolkata and Chennai it will cost Rs 2,174.50 and Rs 2,234.50 per cylinder respectively.

of 19kg commercial cylinder after 2012-13 when it used to cost around Rs 2,200 per cylinder. However, there is no increase in prices of other domestic cylinders weighing 14.2kg, 5 kg, 10kg composite or 5kg composite cylinders.

LPG Cylinder Rate is revised monthly for all over the States and Union Territories in India.

Earlier on November 1, prices of 19kg Commercial cylinder has seen a steep rise of Rs 266, increasing the prices to Rs 2,000.50. On October 1, prices of 19kg commercial cylinders were increased by Rs 43 and decreased by Rs 2.50 on October 6. On September 1, the prices of these This is the second-highest price cylinders were increased by Rs 75.

Bajaj Auto reports 10% decline in **November sales**

Dajaj Auto on Wednesday Breported a 10 per cent decline in its total wholesales at 3,79,276 units in November 2021. The company had dispatched 4,22,240 units in the same month a year ago.

Domestic sales last month fell 20 per cent to 1,58,755 units against 1,98,933 units in November last year, Bajaj Auto said in a statement. The total two-wheeler sales slipped 12 per cent to 3,38,473 units compared to 3,84,993 units sold in the year-ago period. However, the total commercial vehicle sales increased by 10 per cent to 40,803 units from 37,247 units in the same month last year, the company said. The total exports last month, however, witnessed a marginal decline of 1 per cent to 2,20,521 units against 2,23,307 units sold in the corresponding month last year.

The Reserve Bank of India (RBI) on Tuesday moved L quickly towards the process of finding a resolution for Reliance Capital Ltd (RCL) whose board was superseded on Monday. The regulator appointed a committee to advise the administrator of the non-bank lender.

The RBI is shortly expected to move the Mumbai bench of the National Company Law Tribunal (NCLT) to initiate the corporate insolvency resolution process (CIRP) against RCL. In October, the RBI had filed an application with the Calcutta bench of the NCLT within four days of superseding the board of Srei Infrastructure Finance and Srei Equipment Finance.

In a statement, the central bank said that it has set up a threemember advisory panel to assist the administrator - Nageswara Rao Y, the former executive director at Bank of Maharashtra.

The committee includes Sanjeev Nautiyal, the former deputy managing director of the State of Rs 18.10 – a drop of almost 5 Bank of India and Srinivasan Varadarajan, ex deputy managing



director of Axis Bank. The third member is Praveen P Kadle, the former managing director and CEO, Tata Capital Ltd.

RBI APPOINTS COMMITTEE TO ADVISE RELIANCE

After the RBI had superseded the board of RCL, the company had said that it will fully co-operate with the administrator for the expeditious resolution of its debt. Meanwhile, Anil Ambani has reportedly resigned from Reliance General Insurance as the nonexecutive director. Shares of RCL were locked in at the lower circuit per cent over its last close.

It is feared that public

shareholders who hold more than 97 per cent of RCL will be the worst hit. Of these, while retail shareholders hold around 57.53 per cent, high net worth individuals with more than Rs 2 lakh of shares have 27.42 per cent. The rest is spread among insurance companies (that includes LIC with 2.98 per cent), foreign portfolio investors and Ramakrishna Reddy Chinta among others. The focus has now turned to whether RCL will be sold as a single entity, including the holding of its subsidiaries, or whether some of its key businesses will be sold separately.



DATTATREYA STOR

attatreya, or Sri Datta, as he is also referred to, is a Hindu deity who is also regarded as an aspect of the Divine Trinity or Trimurti of Brahma, Vishnu and Maheshwara. The name "Dattatreya" is derived from two Sanskrit words, Datta (which means "given") and Atreya (which refers to the sage Atri, who was also Datta's biological father).

In the Nath tradition of Hinduism, Dattatreya is considered to be an avatar or reincarnation of Lord Shiva and is revered as the Adi-Guru or the First Teacher of the Adinath Sampradaya of the Nath sect of followers. Dattatreya first emerged as a teacher of Yoga, with clear Tantric traits. But later, he was accepted and absorbed into many other cults and sects, even including the more conventional Vaishnavism. He is also considered more of a God today, than a teacher. Today, this deity is worshiped by a multitude of Hindus from all walks of life, spanning the entire globe.

Data is believed to be the author of the Tripura Rahasya, a treatise on Advaita Vedanta, which was given to Parashurama. Lord Dattatreya's birthday is celebrated in a big way as Dattatreya Jayanti.

Dattatreya is regarded as one of the most ancient deities. The earliest references to him can be found as far back as in the Ramayana and the Mahabharata. The Dattatreya Upanishad, which is part of the Atharva Veda, describes him as variously taking the form of a child, a madman and even a demon, in order to help his followers attain moksha (liberation) from the material world.

In the earliest Tantric traditions, this deity was portrayed with only one head. Gorakshanath was responsible for including Sri Datta in the Nath Sampradaya and giving the deity a socially acceptable form today. The current three-headed form of Guru Sri Datta was probably introduced in the last 900 years or so.

Lord Dattatreya's Childhood

Young Datta left his home at a very tender age, to roam naked in search of the Absolute One. He wandered around Gujarat, Maharashtra, North Karnataka and Andhra Pradesh. He is believed to have attained enlightenment in a town in Karnataka, known as Ganagapura. It is also said that his original footprints can still be seen in a lonely peak at Girnar.

Even the treatise Tripura Rahasya refers to Parashurama finding Dattatreya meditating on a peak on the Gandha Madana Mountain.



Dattatreya as an Avatar of the Trinity

Three of Dattatreya's closest disciples were kings. While one of them was an Asura, the others belonged to the Kshatriya (warrior) clan. Dattatreya was at first regarded as an avatar of Shiva. But later, Vaishnavites claimed that he was an avatar of Vishnu. But many Hindus regard both Shiva and Vishnu's as two aspects of the Absolute Brahman. Hence, he went on to identify with the Trinity themselves.

Interestingly, the Dattatreya Upanishad first introduces him as being one with Vishnu and ends with the mantra, "Om Namah Shivaya", thereby also identifying him with Shiva. Towards the end of the third chapter, it says that Shiva pervades all reality and resides as the Eternal Jyoti (Divine Light) in the heart of every man. Shiva is described here as being omnipresent and omniscient. Finally, the chapter closes with the description of Shiva as of being that of Dattatreya.

In the Dasham Granth, Guru Gobind Singh describes Dattatreya (Datt Muni/ Datt Dev) as being the incarnation of Rudra, the Supreme Power. This treatise also narrates the entire life story of Datta.

Appearance of Dattatreya

Shri Dattatreya is portrayed in different ways in different traditions among the Hindus. However, the most commonly portrayed image as having six hands; the lowest two hands holding a Mala (garland) and a Kamandalu (water pot). The middle two hands are shown holding the sacred Shankha (Conch) and Chakra (Discus). Occasionally, portraits also show him holding the Gada (Mace). He is also shown as accompanied by 4 dogs and a cow.

Significance of the Form of Lord Dattatreya

Dattatreya is shown having 3 heads and a form that resonates peace and serenity. In the present Kali Yuga, it is only through pure, divine love, that one can go beyond just being poised and actually attain that type of calmness and serenity. Only those extremely Dharmic (righteous) can follow the fourfold path of Yoga and go ahead to discover the Absolute Truth. Guru Datta radiates that very love and compassion, thereby emanating that peace and love from his person.

The 3 heads of Shri Guru Datta are said to embody his identity as the Devas of the Trinity, namely, Brahma, Vishnu and Shiva. He is also the one who has transcended the 3 qualities or the Triguna and is one with the Sublime Energy of the Absolute Guru. This is why he is also regarded as the Teacher or the Divine Guru.

Sri Dattatreya's 6 Hands

Dattatreya is most often shown as having 6 hands, each holding the Shankha, the Chakra, the Gada, the Trishul (Trident), the Kamandalu (water pot) and the Begging Bowl. Mentioned below is the significance of each of these items:

The Shankha

The Shankha or the Conch is the one that resonates with the Naada, the divine sound. "Sam" and "Kham" together stand for Jupiter and Saturn. Saturn stands forms the basis of knowledge spiritual expansion, which is ultimately bestowed by Jupiter. Likewise, the teacher too is responsible to first awaken the need for gaining knowledge in the student and then helping him or her seek extensive training to achieve the same.

The Chakra

The Chakra, the Discus or the Wheel stands for time or the Kalachakra. The teacher presides over this factor too, by training the student to gain knowledge regarding the time factor, also teaching him to adapt equally to both good and bad times in his life, without getting affected by either. Developing a sense of timelessness leads the follower to Ananda or bliss. The Gada

The Gada or the Mace is symbolic of pride. Pride has to be sacrificed in order to walk the path of the Truth. Dattatreya leads his followers with love and compassion, gently nudging them when they err from the path of Dharma, reminding them to put down their pride and develop love and compassion for other being, thereby experiencing spiritual enlightenment.

The Mace also symbolizes the inverted form of the cerebro-spinal system in our bodies. Guru Datta holding the mace indicates him reversing human conditioning, to free the devotee of his ignorance, finally leading him toward enlightenment.

The Trishul

The Trishul or the Trident symbolizes the triple energies of Ida, Pingala and Sushumna, which are contained in a subtle form within the Brahmadanda. The Ida at the left, gives right to materialization; the Pingala at the right, to spirituality; and the Yogic Sushumna, being the central energy current, works to balance out both these right and left energies. Datta holding the Trident, represents the promise he makes to his followers, to balance out their energies in a way that helps them lead the best life possible, in terms of material pleasure as well as spirituality.

The Kamandalu

The Kamandalu or the little water pot indicates that Guru Datta is, in fact, the life carrier. He bestows a good and long life on the student, so that it can aid him in his spiritual journey; his journey along the Path of the Truth. The Master breathes this life-force into his student, thereby helping him perform his daily Yogic practices, finally raising his Kundalini and giving him the moksha that he seeks.

The Begging Bowl

Finally, the begging bowl that Datta holds; signifies that he begs followers to donate their ego, limitations, pride, negativity, evil thoughts and sickness to him, thereby enabling them to be free of the same. Guru Dattatreya then drinks down this "poison" and helps his bhaktas be liberated from all forms of negativity and evil, thereby putting them more firmly on the path toward enlightenment. Incidentally, Lord Shiva is also sometimes portrayed to be carrying a begging bowl for the same reason.

Avadhuta Gita

According to the Nath Sampradaya, the Avadhuta Gita is a work compiled from the words uttered by Dattatreya, which had been transcribed by his two disciples, Swami and Kartika. Even greats like Swami Vivekananda are said to have held this book in high esteem.

Some of the ideas in this treatise is similar to Shaivite philosophy, Vaishnavite Agamas and Buddhist Tantra as well.

SHODASHOPACHAR PUJA WHY SHOULD AKSHATA NOT BE OFFERED TO A CONCH?

■he conch in a puja has been given the position of the indestructible Brahman. One whose sound symbolises all-encompassing characteristics and is a consequential symbol of pervasiveness, the conch has been honoured by giving it the position of Shiva in the form of Brahman. The conch, which itself is a symbol of activity of supplication, meaning, it is in an awakened state, needs no awakening through the sagun \Box all-encom- waves in the water. Thus, they

While performing puja of a conch why should it be filled with water ?

The dormant sound waves situated in the void of the conch acquire a flowing nature and obtain momentum due to the contact with the Apa-tattva (Absolute Principle)-predominant Water

Puja of the conch (that is filled with water) increases the emission capability of the Chaitanya-predominant marak (Destroyer) waves emitting from the conch, and this leads to purification of the premises. The most valuable thing in life is life itself, but mankind is likely to make the mistake of imagining that the value of life can be enhanced by accretions from outside. What we call life is a completeness by itself, and it does not stand in need of any attribute or adjective to make it complete. The fact that life is a mysterious wholeness and the idea that it needs additional requirements to make it more complete is an error that comes to high relief with a carefully conducted analysis of our own nature.

We do not stand in need of anything to make us complete. This is a truth that we usually forget. And as a matter of fact, nothing can make us complete by a mathematical addition of quantitative or magnitudinous operations. Any amount of addition of material possession or quantity of any kind cannot make us complete,

because our existence is inseparable from the principle of life.

The life that we are living or leading is an inscrutable something which is identical with what we are. On ultimate analysis, we come to know that life is not a process of acting, doing or functioning, but something identical with our own essential being. Inasmuch as life and our existence seem to be inseparable, living a successful life would mean living in such a way as to be in consonance with the characteristics of our own nature. There can be nothing more difficult in life than to live life itself. It is easier to achieve feats which will evoke public approbation than to merely live life, because of the fact that it is identical with our own self. To conduct oneself is more difficult than to conduct a huge army in the battlefield. We can order the march of a huge garrison in the field of battle, but we cannot order a proper



movement of our own personalities in the field of life itself.

The reason behind this difficulty is that our activities, when they are directed to our own selves, become inseparable from our own selves. We are used to regarding life as something other than ourselves. We are accustomed to regarding the world as something different from ourselves, to clinch the whole matter. We are habituated to thinking that activity of life and our personal existence are two different things, so one can afford to be something inside, and another thing in public activity. What a pity! It has been wrongly assumed by people, by almost everyone in the world, that activity, function, or

an office in which one is working has nothing to do with one's own existence or being. This is the reason why we imagine that it is possible for us to behave in a particular way in outer life, inconsistent with what we are in our own inner life. Most people in the world are schizophrenics in the metaphysical sense because they have a double life. It is rare that we find a person who has a single life to live. Everyone has a twofold life-one public life, another private life. This is the malady of life. The greatest disease conceivable is what is called psychological schizophrenia—a split personality, as they call it in psychoanalysis. It is when a mind assumes two properties,

two artificial individualities, and conducts itself in a twofold manner, as if it is two different things altogether; and this malady has managed to infect the lives of people by affecting the very function of the understanding itself.

The greatest endowment of the human being is rationality. We have no property more precious than the power of understanding, logical decision and the ratiocinating capacity. But if the disease sits in that passage, then our thought itself would be diseased. This means to say that when the fundamental instrument of knowledge-which is the basic faculty of all human operations in life-gets affected by a disease, the existence of the disease itself cannot be detected. When a defect gets identified with the nature of our consciousness, it becomes part of ourselves; therefore, we cannot discover the existence of this defect. We cannot

know where the mistake lies in our own nature because of the fact that this mistake has become a part of our existence and consciousness.

Observation of the existence and characteristic of this defect of our personality is impossible because it is not an object of our observation; it is our own selves. We are used to empirical observations, examination through a telescope or a microscope in a laboratory, of objects which are other than our own selves, and we have never been taught how we can observe our own selves through a novel type of telescope or microscope. How can anyone know what mistake is involved in one's own life when that mistake has become a part of one's own nature-when it has become inseparable from one's own skin? This is the crucial question of life and unless this problem is solved, no other problem in the world can be solved.


Admiral Hari Kumar takes charge as new Navy chiet

Centre Wednesday he assured the Delhi High Court that nothing is happening to Delhi Waqf Board properties in the vicinity of the ongoing Central Vista Redevelopment Project.

Solicitor General Tushar Mehta urged Justice Sanjeev Sachdeva to adjourn for three weeks the Board's plea seeking preservation and protection of its heritage properties that are likely to be impacted by the project and said that being a long plan, the redevelopment has not reached the properties in question.

"Kindly have it after three weeks. Nothing is happening to these properties. My learned friend (petitioner) can rest assured. We are before your lordship. It is a very long plan and we have not reached anywhere near it," said the solicitor general who represented the Centre.

The court adjourned hearing in the case till January 20, saying it has full faith in the Solicitor General and turned down the request of the senior lawyer representing the petitioner to take the statement on record.

In its petition, the Delhi Waqf Board represented by



senior advocate Sanjoy Ghose of the Vice President of India.

-- has sought the preservation and protection of six of its properties in the area in which the redevelopment work is ongoing -- Masjid Zabta Ganj at Mansingh Road, Jama Masjid at Red Cross Road, Masjid Sunehri Bagh Road Near Udyog Bhawan, Mazar Sunehri Bagh Road behind Moti Lal Nehru Marg, Masjid Krishi Bhawan inside Krishi Bhawan Compound and Masjid Vice President at the official residence

Claiming that the six properties are more than an ordinary mosque and have a distinction attached to them, the petition has stated that neither the British Government nor the government of India ever created any hindrance in the observance of religious practices at these properties which were always preserved.

The waqf properties, subject matter of the present petition, are all more than 100 years old and

are continuously being used for religious purpose. It is not the case that the Government Buildings were built first and thereafter these properties came into existence, to the contrary, these properties were well in existence when the Government buildings were constructed around them or in the vicinity, the petition filed through lawyer Wajeeh Shafiq has claimed. In September, the court had granted time to the Centre to state

its stand on the petition.

OMICRON VARIANT: RESUMPTION OF INTERNATIONAL FLIGHTS POSTPONED

The government on Wednesday decided not to resume scheduled international flights from December 15, less than a week after announcing the decision in the wake of rising concerns over the COVID variant Omicron.

Aviation watchdog DGCA said the effective date for resumption of scheduled commercial international passenger services will be notified in due course. Scheduled international flights remain suspended since March 23, 2020, due to the coronavirus pandemic.

The latest move also comes after Prime Minister Narendra Modi on November 27 asked officials to review the plans for easing international travel restrictions amid concerns over Omicron.

In a circular on Wednesday, DGCA said that in view of the evolving global scenario with the emergence of new Variants of Concern, the situation is being watched closely in consultation with all stakeholders.

appropriate decision "...an indicating the effective date of resumption of scheduled commercial international passenger services shall be notified in due course," the Directorate General of Civil Aviation (DGCA) said. The watchdog also referred to its circular issued on November 26 wherein it was decided that scheduled international flights will resume from December 15.

On November 28, a day after the Prime Minister's directions regarding the easing of international travel curbs, the government had said the decision to resume the services will be reviewed. While no cases of Omicron have been reported in India so far, the authorities have put in place stricter norms for international passengers.

On November 29, Civil Aviation Minister Jyotiraditya Scindia said the situation was being closely monitored and reviewed in consultation with other ministries regarding "any further decision" on resuming scheduled international passenger services.

Pawar to be the chairperson of the Congress-led United Progressive Alliance (UPA), Banerjee said, "Three is no UPA now."

Earlier on Tuesday, Mamata had met Shiv Sena leaders Aaditya Thackeray and Sanjay Raut.

The meeting was seen as an outreach to fellow Opposition leaders by the Trinamool Congress supremo. Mamata was scheduled to meet Chief Minister Uddhav Thackeray earlier, but as he is unwell, she met his son and minister Aaditya Thackeray, sources said.

Aaditya also gave her a copy of a coffee-table book of his father's photographs, sources added.

Earlier in the day, Mamata visited the famous Siddhi Vinayak temple here. The West Bengal Chief Minister also paid her respects at the memorial of police constable Tukaram Ombale who died fighting terrorists during the 2008 Mumbai terror attack.

Gujarat displaces Maharashtra to become largest manufacturing hub in country

ujarat has emerged as the Juiggest manufacturing hub in India with the state's Gross Value Addition (GVA) in manufacturing growing at 15.9 per cent annually on average between FY'12 and FY'20 to touch Rs 5.11 lakh crore, displacing Maharashtra, according to data released by the RBI. Maharashtra's annual growth rate during the period was 7.5 per cent, taking the state's total manufacturing GVA to Rs 4.34 lakh crore in FY'20. Maharashtra continues to lead as the nation's biggest services hub.

The worst performers among states which were already among the top ten manufacturing states during the period were Rajasthan, Telangana and Andhra Pradesh, with average annual growth rates of 3.8 per cent, 5.5 per cent and 6.9 per cent, respectively during the period. The GVA is essentially GDP minus net product taxes, and reflects growth in supply of goods and services. The other states with the highest manufacturing GVA



were Tamil Nadu at Rs 3.43 lakh crore, Karnataka at Rs 2.1 lakh crore and Uttar Pradesh at 1.87 lakh crore. India's manufacturing GVA grew to Rs 16.9 lakh crore in FY'20 at an average growth rate of 9.7 per cent since FY'12.

Higher investment in Gujarat during the period likely played a key role in allowing the state to outpace the rest of the country in manufacturing growth.

Gujarat witnessed the highest level of capital investment in terms of gross fixed capital formation (GFCF) - a measure of investments – between FY'12 and FY'19 at a total of Rs 5.85

lakh crore ahead of Maharashtra which saw investment of Rs 4.07 lakh crore during the period and Andhra Pradesh which witnessed a cumulative GFCF of Rs 1.49 lakh crore.

A report by KPMG noted that key reforms by Gujarat, including the introduction of a single window for business clearances, easing of labour norms as well as smoother administration of incentive schemes, contributed to boosting ease of doing business in the state and making it one of the country's most attractive destinations for Foreign Direct Investment.

Odisha announces social security scheme for newspaper hawkers

cknowledging the important role that newspaper hawkers Role that newspaper nawkers play in dissemination of information and news, chief minister Naveen Patnaik on Tuesday announced a social security scheme for them. The scheme that offers financial compensation to the nearest kin of the hawkers in the event of their natural or accidental death will benefit hawkers registered under the Odisha Unorganised Workers' Social Security Board. Under the scheme, the kin of registered hawkers will be provided with accidental death benefit of Rs 2 lakh and natural death benefit of Rs 1 lakh. Besides, Rs 1.5 lakh compensation will be provided to hawkers in case of complete disability caused by an accident. In case of partial disability, a hawker will be provided with Rs 80,000, if he/she loses both limbs in any mishap and Rs 40,000 for loss of one limb. Keeping in view the financial problems the hawkers are facing owing to the pandemic, the state government has also decided to provide special financial assistance of Rs 3,000 to each hawker.
